- Muskingum Watershed Conservancy District (MWCD) Cover Crop Cost Share Program is offering \$12.00/acre in the jurisdictional boundary of the MWCD.
- Please read the entire application as agreements have changed.
- **Cap of 200 acres per applicant.** Producers enrolled in the program for two (2) consecutive years, but who planted zero (0) acres, will be capped at 50 acres approved for 2018.
- Complete Table 1 on the back of this application.
- Supply FSA maps of fields list on Table 1 with complete application.
- Soil tests must be within the last 3 years. If answering “No” to Question 9 in Table 1, supply soil tests for review with LCSWCD staff to discuss results.
- Submit application to Licking County Soil & Water Conservation District (LCSWCD) prior to the deadline of July 2, 2018. Application will be date stamped with received date.
- Applications will follow a ranking process.
- Sign agreement once application is approved and prior to release of payment.
- Seeding will take place by the NRCS specification dates for selected cover crop. **Plantings that do not follow NRCS standards such as seeding rates, dates and approved methods will not be eligible for this program.**
- **Participant will notify the SWCD within 5 days of field(s) being planted.**
- **Seed must be tested for germination and weed seed content by ODA to be used in this program.**
- **Plantings that are total failures due to herbicide carryover will not receive the approved cost share for that field(s).**
- Provide any necessary requested information to LCSWCD as needed.
