- Raccoon Creek-Raccoon Creek study for clearing and snagging of woody debris continues to move forward. Silver Jackets H & H study being completed and shared with Army Corp. There is approximately \$80,000.00 cost share that will be required, SLWCD looking into funding options.

 - 1. Kristy is on the steering committee for this rapidly growing group
 - 2. Tech company reached out to Kristy directly. Two options for wetlands and stream restoration have been submitted. A meeting is scheduled on July 19th with Global Water Director for company to learn more about their requirements for projects and to discuss options provided.
 - 3. Working with Intel to set up a New Albany Business Park meeting with tech companies to educate them about the Licking River & Scioto Watershed. A \$100,000 request has been made verbally to do 9-Element plans for the upper and lower Raccoon Creed 12 HUC watersheds

 - Vehicle procurement- Hawthorne stated we are still researching and looking into possibly buying an older vehicle

 - Credit card use restrictions- stamps.com, Google workspace
 - 1. Hawthorne stated we will be paying for these services out of District Fund due to new credit card restrictions at the Auditors
- e. Grant Sub-Committee- Chair Thompson-
 - 2023 application deadline September 29th
 - 1. No applications have been received yet
- **f.** Program Committee- Chair Byce-
 - Proposed Annual Banquet date: October 10th at The Grove by the River. Board Meeting directly beforehand
 - 1. Discussed changing up normal set up due to larger staff

- g. Policy/Personnel Committee- Chair Goodman-
 - Central Ohio AmeriCorps Program
 - 1. Franklin Soil & Water has received a grant through ServeOhio to start an AmeriCorps program. In the process of getting committees created. There will be 8 host sites with 12 AmeriCorp members this year. Franklin is hiring a program coordinator with AmeriCorp member hiring during the month of Sept. Goal to have members at host sites in Oct. The members will be required to serve 1,760 hours, approx. 32 hours per week over a one-year commitment. Licking SWCD will pay \$9,000 for one member. Responsibilities of the member will be helping with education and outreach.

- i. Legislative Committee- Chair Goodman-
 - State Budget Discussion
 - 1. Update from OFSWCD:

The budget process was completed on June 30th, and here is where things stand: There were no changes from the Senate version of the bill, so:

- 12.5 million in state match
- Earmark at \$4.2 million for statewide use (largely H2Ohio implementation)
- \$4 million in the division's line item
- \$9.5 million in "tipping fees"
- \$60 million for H2Ohio

Other items that may be of interest:

- No carve out for research from H2Ohio
- The MALC at OSU was funded
- State fair line items were funded
- Additional funds were not restored for Ohio Proud, County Agricultural Societies, Hemp at oda
- It appears that some of the money for ODNR was restored in the Senate and stayed through conference.

 - Board agreed to cancel August board meeting due to busy fair schedule
