### **H2Ohio Deadline Extended!**

H2Ohio provides producers cost-saving benefits with financial and technical assistance to implement conservation practices that are proven to improve soil

health and water quality.

Eligible producers can enroll acreage into a Voluntary Nutrient Management Plan (VNMP) and earn a \$10/acre incentive for VNMP development and approval.

Producers can also earn incentives of \$10/acre (Basic) or \$15/acre (Precision) for VNMP implementation.

### **Local Schools Qualify for State Envirothon**

The Envirothon is a high school competition designed to stimulate, reinforce and enhance interest in the environment and natural resources. Students are tested on their knowledge of soils, forestry, wildlife, aquatic ecology and current environmental issues. Envirothon encourages cooperative decision-making and team building. While each student on a team is challenged individually to contribute his or her personal best, the score that counts at the end of the competition is the team score. High School students across the state compete on the local level at one of the five Area Envirothons. The top four teams from each Area Envirothon then go on to compete at the state competition held each year in June for the title of State Envirothon Champion.

Two Granville High School teams and one Watkins Memorial High School team will travel to Hocking Hills College on June 4 through 6 for the State Envirothon! Congratulations and good luck to the Licking County teams!

# Hartford Fair Natural Resources Area Program Highlight: Food Competition- Sweets, Greens & Wild Proteins

Join us at the Natural Resources Area during the Hartford Fair for a week of fun filled activities!

Local chefs, home cooks, foragers this contest is for you! This annual food competition highlights local foods, so recipes must contain locally caught, foraged, or sourced ingredients. The Sweets, Greens and Wild Proteins competition takes place on August 7 from 2:00 - 4:00 pm at the Hartford Fair Natural Resources Area. Prepare the recipe at home or in the campground.

The two categories are:

Wild Game: Must include wild game or fish.

Sweets & Greens: Recipe must include a sweet (such as fruit, honey) and/or a green (such as lettuces, collards).

All items must be legally harvested, gathered, or purchased. One recipe/person/category; all ages welcome. After judging, all entries must be made available for tasting by the audience. Start prepping now!
