### **Board Committee**

Soil and Water is also seeking enthusiastic individuals to serve as members of our new board committee groups:

## **Aq/Rural Committee**

This committee will play a vital role in shaping the future of agriculture in Licking County by providing guidance, offering recommendations, and supporting the development of local agricultural programs and outreach.

Focus areas include long-term agricultural planning through the Ag for Tomorrow initiative, fostering partnerships with organizations such as Ohio Ecological Food and Farm Association and OSU Extension, and supporting youth programming. Members will also promote awareness of cost-share opportunities, help identify needs within forestry education, and advise on agricultural pollution concerns and workshop development.

We are looking for individuals with diverse perspectives and backgrounds in agriculture, including producers, educators, youth representatives, and professionals involved in conservation, organic practices, agritourism, and forestry.

#### **Urban/Stormwater Committee**

This committee will provide insight and guidance on improving stormwater education, internal program development, and regulatory strategies throughout the county. Its purpose is to strengthen collaboration between public, private, and nonprofit sectors to better protect our water resources and support responsible development.

The group will help shape stormwaterrelated educational efforts tailored to urban communities, municipal partners, contractors, developers, and realtors. Members will also advise on training programs such as municipal good housekeeping practices and

contractor certification events like the Clean Contractor Expo. Internally, the group will support the development of streamlined drainage protection processes and help identify equipment and resource needs.

We are looking for participants from a wide range of sectors including local governments, engineering and planning professionals, developers, utilities, and educators.

#### **Education/Outreach Committee**

This committee will help guide the development and enhancement of a variety of programs including classroom and community education, adult workshops, and volunteer opportunities. Members will help shape signature programs like River Roundup, Envirothon recruitment, and backyard conservation efforts inspired by successful models like Franklin Soil and Water Conservation District.

The group will also contribute to the growth of the Stream Team program, guide outreach strategies such as social media and website improvements, and suggest newsletter content. Members will evaluate branding, help maximize use of Land Lab for education, and partner with organizations like Unite for Nature to implement shared programs.

We are seeking a diverse group of members representing several local community organizations. This is a fantastic opportunity to get involved, make an impact, and help foster environmental stewardship across Licking County.

## **CONSERVATION MINI-GRANT**

The Soil and Water Conservation Mini-Grant program is an excellent opportunity to help fund a conservation-based service learning project for schools.

Soil and Water established a Community Mini-Grant program in 2019. Each year, Licking County non-profit organizations have the opportunity to receive up to \$1,000. This is given to allow on-the-ground conservation projects to become a reality for local groups.

Last year, six applications were received from non-profits, local government entities, and/or schools for local conservation projects. \$4,150.00 were distributed to the selected organizations.

The Mini-Grant program is open to non-profit organizations such as schools, watershed groups, local government entities, municipalities, continued on page 3

## **2024 STREAM TEAM BREAKDOWN**

icking County is overflowing with water resources. From lakes, ponds, and wetlands to the miles of streams and rivers, one thing all bodies of water need to support life is proper habitat. Habitat is essential for aquatic populations to grow, feed, and flourish.

The most common threat to high-quality habitat in Ohio is land use change. This includes impacts from riparian clearing, siltation, and channelization. By continuing to monitor these changing habitats, we can help ensure that wildlife and the natural landscape are conserved.

Factors such as substrate, flow, and water quality, among others, are assessed and scored using a metric called the Quality Habitat Evaluation Index (QHEI). This tool is used throughout Ohio to measure how suitable a habitat is for fish populations. The Licking County Stream Team uses a variation of this metric to evaluate the health of our local waterways.

The graph displays habitat quality scores in 2024, ranging from "poor" to "excellent." About 92 percent of the habitats scored above the threshold for a "good" rating. Even more encouraging, nearly 80 percent were rated as

"excellent." These results show that the rivers and streams in Licking County are in great condition.

Protecting stream health means minimizing erosion whenever possible.

Deep-rooted vegetation can help reduce soil loss in areas with mild stream bank erosion, although more severe erosion may require additional strategies. Many effective solutions are available to protect both your land and the stream.

## 2024 Habitat Scores




## **NO FISH SALE**

## **INVASIVE CONTROL GUIDE**

#### **Poison Hemlock**

Keep an eye out for poison hemlock. This invasive and nuisance plant can be seen growing all throughout the right-of-way between roads and property encroachment. The sap of this plant is highly toxic if ingested and can cause skin to blister upon contact. Use extreme caution if you encounter it.



This broadleaf biennial weed can grow a single stem upright 3–8' tall. The white flower heads branch off creating an umbrella shape. The flowering timeframe is early spring to mid-summer. During spring and fall poison hemlock can be found as low-growing resetters.

**Leaf:** Fern-like, green, glossy, and deep pointed lobes

**Flower:** White, umbrella shape, clustered

**Stem:** hollow, smooth, purple spots

**Seed:** yellowish green, round with vertical ridges. Seeds tend to fall near the parent plant.

#### **Control instructions**

Mow spring to early summer to reduce seed production. Chemical control should be done in spring to early summer before bloom. Fall application can also be done on young plants. Clean all equipment of seeds to prevent spread.

## **AUGMENTED REALITY SANDBOX**


Tith a generous donation from Amazon Web Services, Licking County Soil & Water was recently able to purchase an Augmented Reality (AR) Sandbox! An AR Sandbox is a 3D, interactive educational tool that can help users understand many different Earth Science subjects including (but not limited to) geography, topography, erosion, mapping, landforms, and watersheds.

The AR Sandbox is an interactive sandbox that consists of a sand table, a scanner, a computer, and a projector. The scanner detects the height and depth of the sand in real time as it is moved by participants. The computer calculates the appropriate projection which is then displayed on the sand as topographical lines and colors on the contours of the sand below. As participants move the sand, the topographical lines and colors change instantaneously to reflect the new contours of the sand. Participants can also simulate rain, which shows how water flows over land masses and within watersheds.

The AR Sandbox will soon be available to schedule for educational programs and events!

Are you interested in scheduling the AR Sandbox in your educational space or at your next indoor event? The AR Sandbox can be set up in an indoor location with access to electricity. Because the AR Sandbox takes a significant amount of time to move and set
