

# **Farmland Preservation Pre-Application**

Soil & Water receives funds from Clean Ohio as the local sponsor to preserve farmland under the Local Agricultural Easement Purchase Program (LAEPP). An agricultural easement is a voluntary and legally binding restriction placed on a farm. The easement limits the use of the land to predominantly agricultural activity. The land remains under private ownership. The farmland can be sold or passed along as a gift to others at any time, but the restriction prohibiting non-agricultural development stays with the land.

The Clean Ohio Fund celebrates its 25th anniversary in 2025, marking a quarter-century since Ohio voters approved the \$400 million bond initiative that has strengthened conservation, revitalization, and outdoor recreation statewide. As a long-standing public-private partnership, the program has protected green space, preserved family farms, cleaned up polluted sites, expanded trails, and restored vital river corridors—leaving a lasting impact on both natural and urban communities across Ohio.

### Four core programs:

- Clean Ohio Revitalization Fund (brownfield cleanup)
- Agricultural Easement Purchase Program
- Green Space Conservation Program
- Trails Fund


### Statewide impact:

- Nearly 400 brownfield sites cleaned up
- Over 26,000 acres of natural areas preserved
- More than 39,748 acres of family farms protected
- · Over 216 miles of multi-use trails created
- 138,280+ acres of land and 379,000+ linear feet of rivers/streams protected

# **Don't be Salty!**



Winter is on its way and that means snow, ice, and, of course, salt! Road salt is used to keep our roads, sidewalks, and driveways ice-free for safety and easier transportation in the cold months. Road salt is not just good ole' table salt, but a blend of rock salt, heavy metals, and other contaminants that can be harmful to people, pets, and the environment when excessively applied. Learn more about road salt and what you can do to keep you and your family (including the furry ones) safe this winter.

## What can excessive road salt application lead to?

- Entry into stormwater system or natural water bodies
- Wildlife feet can be injured, and ingestion for certain species may have a negative impact on their health.

• Runoff carries the salt into stream, which may negatively impact aquatic plants and animals.

## What can you do about it?

- Be conscientious of the amount of salt used, or if application is necessary or if you can shovel
- Use alternatives that contain less harmful compounds and chemicals
- Protect your pets and personal items by cleaning them off after being outside

## **Call Before You Cut**

Are you interested in harvesting your woods? Creating a wildlife area? Designing a park-like feel on your own property? Local Foresters are able to help you create a plan that best fits your desires.

### **Keep these things in mind:**

Be aware of scams. Many people will attempt to offer you a low price and not the true value of your trees.

- Ensure your resource is reputable and check the call before you cut website.
- Know your objectives, why do you want to harvest? Forest health, profit, safety? A professional forester will help you reach your goals.
- Be knowledgeable about the value of your woods and have an inventory. It is important to work closely with your forester and logger on your plan.
- Contact a local forester for more information and start the harvest process.
