Monarch Butterfly Season







In Ohio, Monarch butterflies migrate from June through September. Monarchs rely on a plant called milkweed as a host plant. Unfortunately, Monarchs are experiencing a decline in population due to habitat loss.


How can you help?

In November, Soil & Water has collection bins for milkweed seed pods. We do this to increase the number of milkweed seeds collected, distributed, and planted. Having more milkweed plants allows more Monarchs and other pollinators to have a habitat to make a pit stop during migration.

In August and September, you can locate any milkweed plants and keep an eye out for these signs indicating they are ready to harvest.

- 1. If the center seam pops with gentle pressure, it can be harvested.
- 2. Store the pods in paper bags; plastic bags collect unwanted moisture.
- 3. Please put the date and county collected on the bag when you turn them in.
- 4. Keep the pods in a cool, dry area until you can deliver them to the nearest collection site.

Reduce Water Usage



August is the hottest month of the year, and the amount of water we use tends to increase. There are many ways that you can help conserve the amount of water you use this summer!

Reducing Indoor usage

- Turn off the sink when not actively using water
- Take shorter showers
- Fix leaky appliances/pipes
- Only run full loads of dishes and laundry

Reducing Outdoor Usage

- Plant native plants that are more drought-resistant
- Install a rain barrel that is connected to the roof downspout
- Water in the mornings, NOT mid-day
- Check the forecast before watering

Conservation Mini-Grant

In celebration of Soil and Water's 75th Anniversary, the Board established a Community Mini-Grant program in 2019. Each year, the program offers up to \$1000 to Licking County non-profits, demonstrating the need and ability to carry out on-the-ground conservation projects. The Mini-Grant program is open to various non-profit organizations within Licking County. The deadline to apply for the 2026 Conservation Mini-Grant is September 26, 2025.
